# 1. Introduction

## 1. Introduction

### 1.1 The Docks of the Future Project

**DocksTheFuture** will receive, from the European Commission, a contribution of about 1.2 million Euros, to define the **Port of the Future**, meant as a near future (2030), which should face challenges related to simplification and digitalisation of processes, dredging, emission reduction, energy transition, electrification, smart grids, port-city interface and the use of renewable energy management.

Considering the long-term experience of its staff in European projects, Circle leads a working group consisting of academic partners as the University of Genoa, Italy and of consulting companies Magellan (Portugal), PortExpertise (Belgium) and Institute of Shipping Economics and Logistics – ISL in Bremen, Germany as research and consultancy partner. The proposal addressed a preliminary research on the Port of Future concept, the definition of several Port of the Future topics to be addressed and their related targets in 2030 and a preliminary list of projects that could be potentially clustered together with the RIA (“Research and Innovation Actions”) retained proposals.



In particular, **DocksTheFuture**:

- **Refines** and tunes the Port of Future concepts, the Port of the Future topics and their related targets in 2030 and the list of projects to be clustered together with the PortForward, PIXEL and Corealis projects
- **Identifies** appropriate KPIs (“Key Performance Indicators”) and relevant monitoring and evaluation of action results
- **Leads** to the “Port of the Future Road Map for 2030” that includes a number of exploitation elements, such as tools for evaluation and transferability of Port of the Future solutions,

R&D and policy recommendations, training packages and the creation of a "Port of the Future Network of Excellence".

**DocksTheFuture Project** – which started in January 2018 and will run for 30 months until June, 30<sup>th</sup>, 2020 – entails a Communication and Dissemination Plan addressing all TEN-T Core and Comprehensive Ports and main port stakeholders.

**DocksTheFuture** will contribute to the European Union's policy to increase the integration of maritime transport and TEN-T Ports into the global logistics chain.

## 1.2 Purpose of the Intermediate Report on Communication and Dissemination Activities (I)

The primary purpose of D4.3 - **Intermediate Report on Communication and Dissemination Activities (I)** is to report on the Communication and Dissemination activities implemented in the first 9 months of the project (January to September 2018) to promote **DocksTheFuture** and its outcomes to the pre-defined target groups (in **D4.1 Plan for the Dissemination and Communication of the Action Results**).

An initial summarised overview of the implemented Communication and Dissemination Activities was included in **D6.1 – Six Monthly Progress Report (I)**, submitted on the 2<sup>nd</sup> of August 2018. The current deliverable provides a more detailed account of the work carried out by **DocksTheFuture** in this domain, with particular emphasis on the fulfilment of the pre-defined Key Performance Indicators and foreseen tasks for the upcoming year of the action's implementation.

The document describes the activities carried out for the purposes of Communication and Dissemination accounting for:


### 2.1 Logo and Visual Identity

## 2.2 Website

- **Project News:** The tab serves the exclusive purpose of centralising all news which are directly related with **DocksTheFuture**;
- **Topics:** The tab is divided by 12 topics. More concretely, it refers to the topics for the definition of the concept of Ports of the Future pre-identified at the proposal stage and updated following the work conducted in the desktop analysis (Work Package 1);
- **Experts:** The tab will include relevant information about the experts, who shall participate in the workshops to validate the project’s results;
- **Port of The Future Network:** includes the description of the three Research and Innovation projects retained for funding under the topic MG-7-3-2017 (COREALIS, Pixel and PortForward), their logo and the link to their websites, within the scope of the collaborative approach established among the three projects and **DocksTheFuture**;





## 2.4 Quarterly e-bulletin

The **DocksTheFuture** e-bulletin, including news and about the project and associated clustering activities is sent through the network contact of the OnTheMosway Portal and newsletter with 1300 registered stakeholders. In addition, the **DocksTheFuture** website includes a form so that interested parties can also sign up to receive the project e-bulletin.

The first e-bulletin was sent on month 9 of the project implementation because the consortium decided to define an overall communication and dissemination strategy, the overall visual identity of the project (logo and templates), to set the C&D tools (website, twitter and others). The idea was to first communicate and make the website alive, and only then communicate the project through the e-bulletin. Furthermore, the consortium decided that delaying the release of the first e-bulletin made sense so as to provide an added value service for the recipients, giving them information about the project outputs and contents, which were not available in the first months of the project.

The first **DocksTheFuture** quarterly e-bulletin was sent on the 12<sup>th</sup> of September of 2018, to 1501 stakeholders. The images below show the first DocksTheFuture quarterly e-bulletin. The next e-bulletin will be sent mid-December 2018.

The first quarterly e-bulletin included three articles, namely:

1. Full steam ahead in defining the concept(s) of Port of the Future: article on the collaborative work developed by *DocksTheFuture*, *COREALIS* and *PIXEL*.

## 2.5 Dissemination Material

The first version of the **DocksTheFuture** leaflet was prepared (namely its graphic design, content and printing of the first batch). ## 2.6 Publications, journalistic articles and overall media relations

Over the course of the action's first 9 months, the Press Manager has created, developed and strengthened relations with the media with the purpose of gaining visibility in the media, spreading a positive image on the project, and to ensure the publication of news about **DocksTheFuture**.

Thus far, the Press Manager has carried out the following tasks with the following results:

- Production of 5 Press Releases, 2 in Italian and 3 in English. The following image is examples of the prepared Press Releases:

**DocksTheFuture: 50 initiatives selected to shape the Port of the Future in Europe.**

DocksTheFuture finished its first rounds of desk research on the Port of the Future concepts, assessing 50 out of 350 proposed projects, studies, strategic plans, among other sources. A first conclusion is that most of these initiatives have the potential to shape and strengthen the Ports of the Future concept with the year of 2030 in mind.

The INEA funded DocksTheFuture project aims at defining the vision for the ports of the future in 2030 and mapping its challenges. The project, as a Coordination and Support action, will assist the European Commission (DG MOVE and INEA) in covering the coordination and networking of research and innovation projects, programmes and policies.

The European Union's maritime transport constitutes a crucial link in the global logistic chains and plays a leading role in international freight transport, serving 40% of the EU's internal trade and 75% of its external trade, maritime transport is an essential element in supporting Europe in maintaining its number 1 position in global trade. Therefore, as a key node of the EU's Trans-European Transport Network, ports have the ultimate objective to fully integrate maritime transport into the global logistics chain.

The desk analysis carried out by the DocksTheFuture project partners, under the lead of PortExpertise, during the first half of 2018, led to the definition of preliminary 2030 Ports of the Future concepts, topics, related targets and potential projects to be studied.

PortExpertise and its project partners Circe, ILL, Magellan and subcontractors, have looked, in the first phase, at several EU projects (Horizon 2020, FP7, FP6, COST, ERDF, INDO, INTERREG, Marco Polo, TEN-T, CEF programmes), non-EU funded projects, studies, white papers, PhD theses etc., held stakeholder consultations, conducted a maritime traffic research and forecast review, and analysed macro trends and perspectives, which eventually added up to the selection of the 50 initiatives that have managed to flesh out the Ports of the Future concepts.

The topics cover a very large scope of themes, including among others, infrastructure, accessibility to and from ports, dredging, emission reduction, energy transition, electrification, smart ports, renewable energy management, digitalisation, port-city relations, safety and the human aspects. As sustainability, corporate social responsibility and good governance are becoming increasingly important, these topics carry quite some weight in defining sustainable projects and initiatives for the Port of the Future that can be nothing else but... sustainable. The UN Sustainable Development Goals and the triple P bottom-line, People, Planet and Profit, play an important role when selecting the preliminary initiatives and projects to be implemented in the Ports of the Future.

\*The important take away of this research is that each topic is related to so many different aspects and other topics. When we say that it is a good idea to build more ships powered by




## 2.8 Ports of the Future Network

The Horizon 2020 call (H2020-MG-2016-2017, Topic: MG-7-3-2017) retained four proposals for funding, due to the need for research "to implement new port concepts, new management models,

and innovative design, engineering, construction and operation technologies solutions for full customer, stakeholder and citizen satisfaction”.

The purpose of the call was two-fold: on the one hand, to implement Research and Innovation Actions to address topics such as, but not limited to, multi-modal optimised cost-effective operations, sustainable maintenance, low environmental impact and, on the other hand to implement a Coordination and Support Action with a view to cluster retained proposals, projects, reports, scientific papers (among others), identify appropriate Key Performance Indicators all of which with the ultimate goal of defining the concept(s) of Ports of the Future. The four proposals retained for funding under the topic MG-7-3-2017) were **DocksTheFuture (CSA), COREALIS (RIA), PIXEL (RIA) and PortForward (RIA).**<sup>3</sup>

Following the expectations of the European Commission, to reach the expected foreseen impacts, namely “reduction of impact on climate change and the environment of port activities, their operational and infrastructural costs, improvement of logistics efficiency and better integration of the port in the surrounding socio-economic area, including city-port relations and the smart urban development of Port Cities (...)”<sup>4</sup> the four projects, hereafter referred to as **Ports of The Future Projects**, have engaged in collaborative work. The **pursuance of a collaborative and integrated approach between the projects in relation to both their technical outputs and communication/dissemination strategy aims at capitalising on the synergies between the projects with a view to be as impactful as possible.**

The four projects initiated the work of preparing an integrated strategy during an online meeting, on the 8th of June 2018, having held three online meetings since. The following is a summary of the implemented integrated activities through the collaborative approach of the **Ports of The Future Projects**:

- Regular conference calls to monitor the implementation of the strategy, define tasks and allocate responsibilities;
- Regular tasks of Social Media Cross Promotion between the projects;
- Preparation of the Document “Clustering Activities: Communication & Dissemination Integrated Strategy” in September 2018<sup>5</sup>;
- Collaborative approach in the promotion of the projects at events and conferences;
- Sharing of information between the four projects to streamline the results and create a cohesive narrative;
- Interaction with European Technology Platforms (i.e. ALICE-ETP);
- Possibility of organising common events.

## 2.9 WP 4: Deliverables

Work Package 4: Dissemination and Exploitation has five associated deliverables, two of them due in the current reporting period:

- **D4.1 Plan for the Dissemination and Communication of the action Results (PDCR):** The Deliverable moves from the preliminary draft plan presented in the proposal, having been updated at the beginning of the project and regularly during the project timeframe, including a record of activities related to Dissemination and Communication (D&C). Related task: 4.1 - Plan for the Dissemination and Communication of the action Results (PDCR).
- **D4.3 Intermediate Report on Communication and Dissemination Actions (I):** The current document.

Deliverable 4.1: Plan for the Dissemination and Communication of the action results (PDCR) was delivered and uploaded in the Participants Portal in May 2018. Magellan produced the Deliverable, having involved all the partners in the revision of the document, and consequently including their inputs. Circle, as the peer-reviewer, completed the corresponding peer review form. The Deliverable considered suggestions given by the DocksTheFuture project officer. The Deliverable consisted both of an update of the preliminary draft plan presented in the proposal stage and of a matured strategy for the dissemination and communication of the project<sup>6</sup>.

The updated version of the Plan for the Dissemination and Communication of the action results (Deliverable 4.2), due in March 2019, will include the necessary changes to the strategy,
